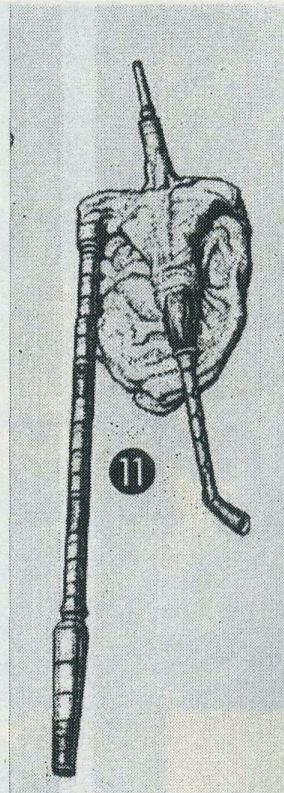

Gajda (Macedonia, Bulgaria)

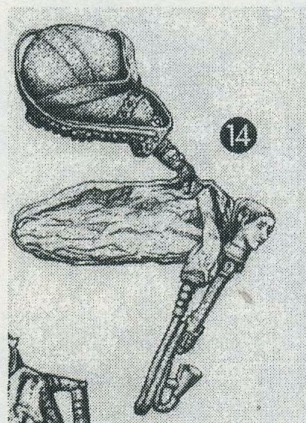
